Message from the Mayor



The results of the city's survey to gauge resident interest in backyard chickens are in, and the majority of respondents were in favor.

A total of 175 people took the survey, but only 158 are city residents. Some 124 respondents support an amendment to let residents keep chickens. And 111 people said they personally would get chickens.

Some 76 of those survey respondents left written comments that run the gamut from enthusiastic support ("Let us have chickens!!!!") to ambivalence ("It's okay as long as there isn't to many roosters.") to vociferous opposition ("They stink. If I wanted to smell like a farm I'd live in the country.")

My problem with the survey is that respondents are self selected, and I suspect those in favor were more likely to respond than those who oppose.

In contrast, the April 2 St. Louis Sentinel story I published about this issue generated five comments from Mark Yourchock, KC Malone, Kevin T, Patricia Crow and Gary Smith. All were opposed.

I've already gone on record as being opposed to letting residents keep chickens and haven't changed my mind.

St. Louis has one ordinance enforcement officer who already has plenty to do. I don't want to add chicken coop inspector to her duties. No one was clamoring for the right to keep chickens before my council colleague Liz Upton brought it up.

We already have residents who can't keep their dogs under control. As an avid walker I've been threatened by dogs at least twice a year and started carrying Mace for defense. I shudder to think what problems would arise if St. Louis becomes the barnyard capital of Gratiot County.

An old saying comes to mind: "If it ain't broke, don't fix it."
