TRAINING:

- O6/06/2019 Officers Rugenstein, VanHall, Bahlke and Morell attended the Solo Response to Active Shooter training in Livonia, MI. This training required an overnight hotel stay in Livonia. Active Shooter Response tactics have been modified over the last 20 years to meet the challenges of these catastrophic events. Officers must plan and train for every type of contingency, whether it is the first officer arriving on the scene, a pair of officers, or an organized team, each response must be trained and rehearsed to minimize confusion and optimize effect. This course was designed to prepare a first responder to arrive, assess and approach the scene of an active shooter with knowledge and abilities to take appropriate action to mitigate the consequences of these types of events. The training course covered:
 - o -Lecture
 - o -Demonstration
 - -Isolation exercises
 - o -Reality-based scenarios
- 06/10/2019 Sgt. Forshee, along with several members of the Gratiot County Child Forensic team and Child Protective Services attended the Michigan Child Death Review training at the Kellogg Conference Center in E. Lansing. This training covered investigations of Child Deaths/Sudden Unexplained Infant Death, the role of the investigator in child death investigations, re-enactments and prosecution.
- 06/17/2019 Officers VanHall, Morell and Hoy attended a Threat Focused Shooting training at the Midland Law Center. This training covered spontaneous shooting situation that occur in close quarters. The majority of the time within 3-7 yards, where most documented police shootings occur. The basis for this program is taken from the teachings of Lt. Col. Rex Applegate and his program of Combat Point Shooting. This program is a "hands on" training that utilizes "Airsoft" weapons which will be supplied for the training. The training covered tactics, lessons learned, mental/physical preparedness, use of force and legal aspects.
- 06/18/2019 Ofc. Hoy attended the Bullet Proof Mind training hosted by the Northeast Counterdrug Training Center. The training was held in Swartz Creek, MI. The guest speaker was Lt. Col. Dave Grossman of the Warrior Science Group and is considered the nations foremost expert in the field of human aggression and the roots of violence and violent crime. The training covered Post Traumatic Stress indicators and management; surviving gunshot wounds; survivor guilt, new killers in the 21st century, training drills & tactics; violent visual imagery; reality vs. fantasy; games that are more dangerous than movies.

 O6/28/2019 Sgt. Forshee and I attended the Medical Examiner Investigator (MEI) training at the Gratiot County Court House. This training was also attended by members of the Gratiot County Sheriff's office, Breckenridge and Alma Police Departments. This training is the result of the new partnership between Gratiot County and the Genesee County Medical Examiners office. The medical examiner (ME) is the person in charge of the forensic investigation of a death that has occurred in his or her area of jurisdiction, whether it is a homicide, suicide, accident, or other suspicious death. He or she has several tasks to carry out, chief of which is the determination of the cause and manner of the death through performing an autopsy. The medical examiner also takes charge of the analysis of evidence, works with the police investigating the scene of the crime, and presents evidence in court. In short, the ME is involved in both the medical and legal sides of a forensic investigation. The MEI is the on-scene investigator that works directly with the ME. A second training will be scheduled for July during which the remaining St. Louis Police Officers and members of the other Gratiot County Law Enforcement agencies will be trained as MEI's. See the attached article from the Gratiot County Herald for more information on this partnership.

MISC:

- 06/10/2019 I did a short presentation to the Gratiot County Substance Abuse Coalition (GCSAC) on recent legislative changes on Vaping (Senate Bill 155 & Senate Bill 106). See attached document for synopsis of my presentation
- 06/13/2019 Mayor Kelly and I went to the Nikkari Elementary and presented to the 3rd grade classes. Members of the St. Louis Historical Society were also part of this. The students were originally supposed to come to City Hall for a tour but due to the inclement weather, we went to them instead. There were 3 classes that we spoke to. We each presented to a class separately and rotated through all 3 classes. This was very well received and a great time!
- 06/19/2019 I hosted a demo from WatchGuard Inc. WatchGuard provides in-car and body camera solutions for law enforcement. This was a chance to see first hand the products and software WatchGuard has to offer for law enforcement. We had 19 attendees from multiple police agencies and law enforcement vehicle up fitters.
- 06/24/19-6/27/19 Sgt. Forshee and Ofc. Crowther participated as instructors at the annual Gratiot Youth Police Academy. Members of the Gratiot County Sheriff's Office, Alma Police Department, Michigan State Police, DNR, MMR, Breckenridge, St. Louis, Alma and Ithaca Fire departments were also represented as instructors. There were approximately 55 youth from across Gratiot County that attended this week-long training.
- 06/25/2019 I hosted the CORE regional workshop. CORE is the software and report management software provider for law enforcement in Gratiot County and multiple other law enforcement agencies across Michigan. This is a yearly event that CORE does for their clients to cover tips/tricks, updates and provides an opportunity for their clients to seek assistance in the various platforms utilized by law enforcement. We had attendees from all law enforcement agencies and the courts in Gratiot County plus agencies from Isabella County.

<u>Senate Bill 155</u>, introduced by State Sen. Marshall Bullock II, D-Detroit, would require liquid nicotine products to meet federal child-resistant standards and would levy a misdemeanor with a \$50 fine for anyone selling a product that didn't meet the standards. Under the bill, nicotine products would have to be stored behind the counter or in a locked case, and anyone who violated those standards would have a state civil infraction and a fine of \$500.

<u>Senate Bill 106</u>, introduced State Sen. Rick Outman, R-Six Lakes, amends the Youth Tobacco Act to lay out the penalties for a minor possessing e-cigarettes or other nicotine products and for someone who sells or gives e-cigarettes to minors.

Bills 106 and 155

- passed in the Michigan Senate on April 23, 2019
- passed in the Michigan House on May 15, 2019.
- EFFECTIVE SEPTEMBER 2, 2019
- The amendments passed define e-cigarettes as "vapor products" that use a heating element, often powered by a battery, to create nicotine vapors which are inhaled.
- The bills also require store clerks to verify the age of anyone who appears to be under the age of 27 by examining a government issued ID card.
- For online sales, the seller must use an independent third-party age verification service that compares information from commercially available databases used by government agencies and businesses.

This will clarify that it is illegal to sell e-cigarettes and other non-traditional nicotine products to minors

- The law will prohibit retailers from selling a "vapor product" or "alternative nicotine product" to anyone under the age of 18 years old and creates penalties for doing so
- require child-resistant packaging on liquid nicotine containers.

SB 106 creates two new categories of nicotine products—"'vapor products' and 'alternative nicotine products'

• Whitmer said. "In doing so, it separates e-cigarettes from the definition of tobacco products in a way that could be used to exempt these products from evidence-based tobacco control."

SB 155 makes it a misdemeanor for a person to sell a liquid nicotine container unless it met federal child-resistant effectiveness standards.

- Retail stores selling vapor products must keep products displayed behind a counter in an area only accessible to employee or within a locked case.
- The amendment also requires stores to post a warning sign produced by the Michigan Department of Health and Human Services with revised language to include vapor products and alternative nicotine products. The sign must include a specific statement warning the purchase of tobacco products by a minor is illegal.

Penalties

The law will create new fines for selling e-cigarettes to minors

- up to \$100 for a first offense
- \$500 for a second offense
- \$2,500 for a third or subsequent offence.

Penalties for traditional tobacco sales to minors would be raised to match those fines, and retailers would also be required to post signs explaining the illegality of selling tobacco products to minors.

Retailers would also be required to check identification for e-cigarette sales and would require childresistant packaging for liquid nicotine.

Statistics

2018, 21% of American high school students and 5% of middle school students—children as young as 12—reported having used e-cigarettes or other vape products in the last 30 days

e-cigarette sales to high school students increased 78% from 2017 to 2018.



June in the village of Ashley was a little quieter this year.

There was no car show, no tractor pull, and no fire department barbecue. The 2019 Ashley Trading Days had been cancelled.

The only part of the nearly 27-year-long tradition that remained was the town-wide garage sale.

But village president Ann Paksi pointed out that Ashley is far from alone in their community event woes.

"I think all little towns are struggling with their festivals," she said.

Paksi's observation rings true throughout Gratiot County this year: Ithaca called off plans for a full Fun Fest this fall, and St. Louis' 2019 Blues Festival has also been cancelled.

Various factors led to the decisions to put the events on hold.

dwindling attendance and mounting expenses, Paksi said. The town's small population — especially the lack of "young people" — meant that the festival had to come up with different ways to attract visitors.

The event "went into the hole big time" last year after a failed attempt to draw in crowds with more expensive vendors and attractions, Paksi said.

And, according to Paksi, when several staples of the festival — like the fire department barbecue, the car show, and the tractor pull — decided not to participate in Trading Days, the decision was made to pull the plug on the event.

Paksi was among those who fought to find a way to make the festival viable. While she said she is sad to see it disappear, she also doesn't know what can be done to save the tradition.

"It's frustrating, because it has been going on this long," she said. "And it's hard to really give it up." See FESTIVALS on page 6 pated Rohrer would stay for two years. He gave them three.

On Monday, Rohrer concluded his tenure at Ashley Community Schools, handing over the reigns to K-12 principal Traci Gavenda.

Citing a desire to spend more time with his family, the 62-yearold informed the board back in March that he wouldn't be returning next school year.

"In the past three years our family has grown," Rohrer recently told The Herald. "My wife Pat and I have many travel plans and we want more time to spend with our grandchildren. The Ashley School District is in a good place and the timing is right."

In the wake of Rohrer's resignation announcement, the board of education elected to revamp its administrative structure by combining the positions of high school principal and superintendent.

The dual role job, commonly referred to as "super principal," is becoming increasingly popular with smaller school districts, instituted locally at Fulton, Vestaburg and Merrill.

For Ashley, the move to restructure provided an in-house candidate in Gavenda, who accepted the position when it was offered to her in April.

County Contracts With Forensic Pathologist So Far in 2019, Gratiot Has Spent \$111,246 on 35 Autopsies

Gratiot County has contracted medical examiner services with a Lansing forensic pathologist.

Dr. Brian Hunter, who is the medical examiner for Genessee and other counties, began the assignment on Monday, July 1.

State law describes a medical examiner as someone who investigates deaths that are sudden, suspicious, unexpected, violent, accidental, occurs in jails or prisons, or happen without medical attention within 48 hours.

County Administrator Tracey Cordes and Commissioner Sam Smith, a mortician by profession, have been researching options for several years. See PATHOLOGIST on page 5

At a 2016 county board meeting, commissioners began discussing the costs the county incurred such as transporting bodies to Lansing Sparrow Hospital for autopsies.

Commissioners at the time reappointed Dr. Kurt Anderson for another four years but began exploring alternatives.

So far in 2019, the county has spent \$111,246 for 35 autopsies.

Commissioner Smith at the June 18 meeting explained only two bids came back from the county's advertisement.

Following some discussion, commissioners unanimously approved an intergovernmental agreement with Genessee County and the appointment of Hunter.

In another motion, the board rescinded the contract with Anderson which would have expired at the end of this year.

A fee of \$1,413 for autopsy and toxicology will be paid on a per case basis. Transportation and administrative fees will bring the estimated costs to \$64,205.

Hunter's staff at Hurley Medical Center in Flint will begin training officers from law enforcement agencies in Gratiot County on tasks associated with medical examiner investigations.

Hunter also is reviewing procedures for handling inpatient deaths with hospital staffs, according to a

written report from Cordes.

Jail To Get New Roof

For another ongoing issue, commissioners hired a company to replace the roof of the jail.

County building inspector Tony Miller led board members through a written comparison of the three bids.

The county asked for proposals to seal the existing fully adhered, reinforced rubber membrane over an insulated concrete deck.

A lengthy discussion led to the selection of WTI-Tremco Roofing. Contract is for \$99,500 and repair cost is not to exceed \$22 per square foot.

THIS CONTRACT is made and entered into this date of <u>DONOT DATE</u>, by and between the MICHIGAN DEPARTMENT OF TRANSPORTATION, hereinafter referred to as the "DEPARTMENT;" and the CITY OF ST. LOUIS, a Michigan municipal corporation, hereinafter referred to as the "REQUESTING PARTY;" for the purpose of fixing the rights and obligations of the parties in agreeing to the following improvements, in the City of St. Louis, Michigan, hereinafter referred to as the "PROJECT" and estimated in detail on EXHIBIT "I," dated June 18, 2019, attached hereto and made a part hereof:

Roadway reconstruction work along Maple Street from W. State Street to Hazel Street; including subbase, base, storm sewer and structure, concrete curb and gutter, and hot mix asphalt resurfacing work; and all together with necessary related work.

WITNESSETH:

WHEREAS, the State of Michigan is hereinafter referred to as the "State;" and

WHEREAS, the PROJECT has been approved for financing in part with funds from the State appropriated to the Transportation Economic Development Fund, hereinafter referred to as "TED FUNDS," qualifies for funding pursuant to PA 231, Section 9(1)(b); Public Act of 1987, as amended, and is categorized as:

CATEGORY "B" FUNDED PROJECT

WHEREAS, the parties hereto have reached an understanding with each other regarding the performance of the PROJECT work and desire to set forth this understanding in the form of a written contract.

NOW, THEREFORE, in consideration of the premises and of the mutual undertakings of the parties and in conformity with applicable law, it is agreed:

1. The parties hereto shall undertake and complete the PROJECT in accordance with the terms of this contract.

2. The term "PROJECT COST," as herein used, is hereby defined as the cost of the physical construction necessary for the completion of the PROJECT.

The costs incurred by the REQUESTING PARTY for preliminary engineering, construction engineering and inspection, and right-of-way are excluded from the PROJECT COST as defined by this contract.

3. The DEPARTMENT is authorized by the REQUESTING PARTY to perform, at no cost to the PROJECT, such administration of the PROJECT covered by this contract as is necessary to assist the REQUESTING PARTY to qualify for funding. Such administration may include performing such review, legal, financing, any other PROJECT related activities as are necessary to assist the REQUESTING PARTY in meeting applicable State requirements.

The DEPARTMENT shall provide the REQUESTING PARTY with a notice to proceed with the award of the construction contract for the PROJECT.

The DEPARTMENT may make a final acceptance inspection of the PROJECT as necessary to ensure the PROJECT meets State requirements. Failure to comply with State requirements may result in forfeiture of future distributions of the Michigan Transportation Fund as described in Section 5. No charges will be made by the DEPARTMENT to the PROJECT for any inspection work or construction engineering.

4. The REQUESTING PARTY, under the terms of this contract, shall advertise and award the PROJECT work in accordance with the following:

- A. The REQUESTING PARTY will, at no cost to the DEPARTMENT or the PROJECT, design, or cause to be designed, the PROJECT, and shall accept full responsibility for that design. Any review undertaken by the DEPARTMENT is for its own purposes and is not to nor does it relieve the REQUESTING PARTY of liability for any claims, causes of action or judgments arising out of the design of the PROJECT.
- B. The REQUESTING PARTY, hereby, certifies to the DEPARTMENT that the plans, specifications, and estimates for the PROJECT have been prepared in compliance with applicable State laws, local ordinances, and State and local standards and regulations.
- C. The REQUESTING PARTY, hereby, certifies to the DEPARTMENT that the contracting procedures to be followed by the REQUESTING PARTY in connection with the solicitation of the construction contract for the PROJECT shall be based on an open competitive bid process. It is understood that the proposal for the PROJECT shall be publicly advertised and the contract awarded on the basis of the lowest responsive and responsible bid in accordance with applicable State statutes, local ordinances, and State and local regulations.

- (1) The REQUESTING PARTY shall not award the construction contract prior to receipt of a notice to proceed from the DEPARTMENT.
- (2) Upon verification that contractor selection by the REQUESTING PARTY was made in accordance with the terms of this contract and upon receipt of the "Request for Payment" form from the REQUESTING PARTY, the DEPARTMENT will authorize payment to the REQUESTING PARTY for the eligible amount in accordance with Section 5.
- D. The REQUESTING PARTY will, at no cost to the PROJECT or the DEPARTMENT, comply with all applicable State statutes, local ordinances, and State and local regulations, including, but not limited to, those specifically relating to construction contract administration and obtain all permits and approvals with railway companies, utilities, concerned State, Federal, and local agencies, etc., and give appropriate notifications as may be necessary for the performance of work required for the PROJECT.

The REQUESTING PARTY agrees to comply with all applicable requirements of Part 91, Soil Erosion and Sedimentation Control of the Natural Resources and Environmental Protection Act, 1994 PA 451 as amended by 1995 PA 60 and 1996 PA 173, MCL 324.9101 et. seq., for all PROJECT work performed under this contract, and the REQUESTING PARTY shall require its contractors and subcontractors to comply with the same.

- E. All work in connection with the PROJECT shall be performed in conformance with the DEPARTMENT'S current Standard Specifications for Construction, special provisions, and the supplemental specifications and plans pertaining to the PROJECT. All materials furnished and used in the construction of the PROJECT shall conform to the aforesaid specifications. Any changes in the scope of work for the PROJECT will require approval by the DEPARTMENT.
- F. The REQUESTING PARTY shall, at no cost to the PROJECT or to the DEPARTMENT, appoint a project manager who shall administer the PROJECT and ensure that the plans and specifications are followed, and shall perform or cause to be performed the construction engineering and inspection services necessary for the completion of the PROJECT.

Should the REQUESTING PARTY elect to use consultants for construction engineering and inspection, the REQUESTING PARTY shall provide a full-time project manager employed by the REQUESTING PARTY who shall ensure that the plans and specifications are followed.

- G. The REQUESTING PARTY shall require the contractor who is awarded the contract for the construction of the PROJECT to provide, as a minimum, insurance in the amounts specified in and in accordance with the DEPARTMENT'S current Standard Specifications for Construction, and to:
 - (1) Maintain bodily injury and property damage insurance for the duration of the PROJECT.
 - (2) Provide owner's protective liability insurance naming as insureds the State of Michigan, the Michigan State Transportation Commission, the DEPARTMENT and its officials, agents and employees, the REQUESTING PARTY and any other party with jurisdiction for the roadway being constructed as the PROJECT, and their employees, for the duration of the PROJECT and to provide copies of certificates of insurance to the insureds. It is understood that the DEPARTMENT does not assume either ownership of any portion of the PROJECT or jurisdiction of any REQUESTING PARTY highway as a result of being named as an insured on the owner's protective liability insurance policy.
 - (3) Comply with the requirements of notice of cancellation and reduction of insurance set forth in the current Standard Specifications for Construction and to provide copies of notices and reports prepared to those insured.

5. The PROJECT COST shall be met in part by contributions by TED FUNDS. TED FUNDS Category B shall be applied to the eligible items of the PROJECT COST up to an amount not to exceed the lesser of: (1) 35 percent of the approved and responsible low bid amount, or (2) \$250,000, the grant amount. The balance, if any, of the PROJECT COST, after deduction of TED FUNDS, is the sole responsibility of the REQUESTING PARTY.

The REQUESTING PARTY shall be responsible for the payment of all costs and expenses incurred in the performance of PROJECT work.

Based upon the final cost of the PROJECT and/or a request by the REQUESTING PARTY, a payment adjustment may be initiated and/or authorized by the DEPARTMENT for eligible items of the PROJECT COST such that the total amount of TED FUNDS does not exceed the grant amount. The REQUESTING PARTY shall certify all actual costs incurred for

work performed under this contract that are eligible for payment with TED FUNDS and will be required to repay any TED FUNDS it received in excess of 35 percent of the total of such costs.

6. The REQUESTING PARTY shall establish and maintain adequate records and accounts relative to the cost of the PROJECT. Said records shall be retained for a period of three (3) years after completion of construction of the PROJECT and shall be available for audit by the DEPARTMENT. In the event of a dispute with regard to allowable expenses or any other issue under this contract, the REQUESTING PARTY shall continue to maintain the records at least until that dispute has been finally decided and the time after all available challenges or appeals of that decision has expired.

The DEPARTMENT, or its representative, may inspect, copy, or audit the records at any reasonable time after giving reasonable notice.

The REQUESTING PARTY, within six (6) months of completion of the PROJECT and payment of all items of PROJECT COST related thereto, shall make a final reporting of construction costs to the DEPARTMENT and certify that the PROJECT has been constructed in accordance with the PROJECT plans, specifications, and construction contract.

In the event that an audit performed by or on behalf of the DEPARTMENT indicates an adjustment to the costs reported under this contract or questions the allowability of an item of expense, the DEPARTMENT shall promptly submit to the REQUESTING PARTY a Notice of Audit Results and a copy of the audit report which may supplement or modify any tentative findings verbally communicated to the REQUESTING PARTY at the completion of an audit.

Within sixty (60) days after the date of the Notice of Audit Results, the REQUESTING PARTY shall: (a) respond in writing to the responsible Bureau or the DEPARTMENT indicating whether or not it concurs with the audit report, (b) clearly explain the nature and basis for any disagreement as to a disallowed item of expense, and (c) submit to the DEPARTMENT a written explanation as to any questioned or no opinion expressed item of expense, hereinafter referred to as the "RESPONSE". The RESPONSE shall be clearly stated and provide any supporting documentation necessary to resolve any disagreement or questioned or no opinion expressed item of expense. Where the documentation is voluminous, the REQUESTING PARTY may supply appropriate excerpts and make alternate arrangements to conveniently and reasonably make that documentation available for review by the DEPARTMENT. The RESPONSE shall refer to and apply the language of the contract. The REQUESTING PARTY agrees that failure to submit a RESPONSE within the sixty (60) day period constitutes agreement with any disallowance of an item of expense and authorizes the DEPARTMENT to finally disallow any items of questioned or no opinion expressed cost.

The DEPARTMENT shall make its decision with regard to any Notice of Audit Results and RESPONSE within one hundred twenty (120) days after the date of the Notice of Audit Results. If the DEPARTMENT determines that an overpayment has been made to the REQUESTING PARTY, the REQUESTING PARTY shall repay that amount to the

DEPARTMENT or reach agreement with the DEPARTMENT on a repayment schedule within thirty (30) days after the date of an invoice from the DEPARTMENT. If the REQUESTING PARTY fails to repay the overpayment or reach agreement with the DEPARTMENT on a repayment schedule within the thirty (30) day period, the REQUESTING PARTY agrees that the DEPARTMENT shall deduct all or a portion of the overpayment from any funds then or thereafter payable by the DEPARTMENT to the REQUESTING PARTY under this contract or any other agreement, or payable to the REQUESTING PARTY under the terms of 1951 PA 51, as applicable. Interest will be assessed on any partial payments or repayment schedules based on the unpaid balance at the end of each month until the balance is paid in full. The rate of interest will be based on the Michigan Department of Treasury common cash funds interest earnings. The rate of interest will be reviewed annually by the DEPARTMENT and adjusted as necessary based on the Michigan Department of Treasury common cash funds interest earnings. The REQUESTING PARTY expressly consents to this withholding or offsetting of funds under those circumstances, reserving the right to file a lawsuit in the Court of Claims to contest the DEPARTMENT'S decision only as to any item of expense the disallowance of which was disputed by the REQUESTING PARTY in a timely filed RESPONSE.

The REQUESTING PARTY shall comply with the Single Audit Act of 1984, P.L. 998-502 and applicable State laws and regulations relative to audit requirements.

7. The REQUESTING PARTY certifies that a) it is a person under the Natural Resources and Environmental Protection Act, MCL 324.20101 et seq., as amended, (NREPA) and is not aware of and has no reason to believe that the property is a facility as defined in the NREPA; b) the REQUESTING PARTY further certifies that it has completed the tasks required by MCL 324.20126 (3)(h); c) it conducted a visual inspection of property within the existing right of way on which construction is to be performed to determine if any hazardous substances were present; and at sites on which historically were located businesses that involved hazardous substances, it performed a reasonable investigation to determine whether hazardous substances exist. This reasonable investigation should include, at a minimum, contact with local, State and federal environmental agencies to determine if the site has been identified as, or potentially as, a site containing hazardous substances; d) it did not cause or contribute to the release or threat of release of any hazardous substance found within the PROJECT limits.

The REQUESTING PARTY also certifies that, in addition to reporting the presence of any hazardous substances to the Department of Environmental Quality, it has advised the DEPARTMENT of the presence of any and all hazardous substances which the REQUESTING PARTY found within the PROJECT limits, as a result of performing the investigation and visual inspection required herein. The REQUESTING PARTY also certifies that it has been unable to identify any entity who may be liable for the cost of remediation. As a result, the REQUESTING PARTY has included all estimated costs of remediation of such hazardous substances in its estimated cost of construction of the PROJECT. 8. If, subsequent to execution of this contract, previously unknown hazardous substances are discovered within the PROJECT limits, which require environmental remediation pursuant to either State or federal law, the REQUESTING PARTY, in addition to reporting that fact to the Department of Environmental Quality, shall immediately notify the DEPARTMENT, both orally and in writing of such discovery. The DEPARTMENT shall consult with the REQUESTING PARTY to determine if it is willing to pay for the cost of remediation and to determine the eligibility, for reimbursement, of the remediation costs. The REQUESTING PARTY shall pay all costs associated with such remediation, including all delay costs of the contractor for the PROJECT. If the REQUESTING PARTY refuses to participate in the cost of remediation, the amount of TED FUNDS the REQUESTING PARTY received from Grant 6 shall be forfeited back to the DEPARTMENT.

9. If State funds administered by the DEPARTMENT are used to pay the cost of remediating any hazardous substances discovered after the execution of this contract and if there is a reasonable likelihood of recovery, the REQUESTING PARTY, in cooperation with the Department of Environmental Quality and the DEPARTMENT, shall make a diligent effort to recover such costs from all other possible entities. If recovery is made, the DEPARTMENT shall be reimbursed from such recovery for the proportionate share of the amount paid by the DEPARTMENT and the DEPARTMENT shall credit such sums to the appropriate funding source.

10. The DEPARTMENT'S sole reason for entering into this contract is to enable the REQUESTING PARTY to obtain and use funds provided by the State.

Any and all approvals of, reviews of, and recommendations regarding contracts, agreements, permits, plans, specifications, or documents, of any nature, or any inspections of work by the DEPARTMENT pursuant to the terms of this contract are done to assist the REQUESTING PARTY in meeting program guidelines in order to qualify for available funds. Such approvals, reviews, inspections and recommendations by the DEPARTMENT shall not relieve the REQUESTING PARTY and the local agencies, as applicable, of their ultimate control and shall not be construed as a warranty of their propriety or that the DEPARTMENT is assuming any liability, control or jurisdiction.

The providing of recommendations or advice by the DEPARTMENT does not relieve the REQUESTING PARTY and the local agencies, as applicable, of their exclusive jurisdiction of the highway and responsibility under MCL 691.1402 et seq., as amended.

When providing approvals, reviews and recommendations under this contract, the DEPARTMENT is performing a governmental function, as that term is defined in MCL 691.1401 et seq. as amended, which is incidental to the completion of the PROJECT.

11. The DEPARTMENT, by executing this contract, and rendering services pursuant to this contract, has not and does not assume jurisdiction of the highway, described as the PROJECT for purposes of MCL 691.1402 et seq., as amended. Exclusive jurisdiction of such

highway for the purposes of MCL 691.1402 et seq., as amended, rest with the REQUESTING PARTY and other local agencies having respective jurisdiction.

12. The REQUESTING PARTY shall approve all of the plans and specifications to be used on the PROJECT and shall be deemed to have approved all changes to the plans and specifications when put into effect. It is agreed that ultimate responsibility and control over the PROJECT rests with the REQUESTING PARTY and local agencies, as applicable. Any changes in the scope of work for the PROJECT will require approval by the DEPARTMENT.

13. The REQUESTING PARTY agrees that the costs reported to the DEPARTMENT for this contract will represent only those items that are properly chargeable in accordance with this contract. The REQUESTING PARTY also certifies that it has read the contract terms and has made itself aware of the applicable laws, regulations, and terms of this contract that apply to the reporting of costs incurred under the terms of this contract.

14. Each party to this contract will remain responsible for any and all claims arising out of its own acts and/or omissions during the performance of the contract, as provided by this contract or by law. In addition, this is not intended to increase or decrease either party's liability for or immunity from tort claims. This contract is also not intended to nor will it be interpreted as giving either party a right of indemnification, either by contract or by law, for claims arising out of the performance of this contract.

15. In connection with the performance of PROJECT work under this contract the parties hereto (hereinafter in Appendix "A" referred to as the "contractor") agree to comply with the State of Michigan provisions for "Prohibition of Discrimination in State Contracts," as set forth in Appendix A, attached hereto and made a part hereof. The parties further covenant that they will comply with the Civil Rights Acts of 1964 being P.L. 88-352, 78 Stat. 241, as amended, being Title 42 U.S.C. Sections 1971, 1975a-1975d, and 2000a-2000h-6, and will require similar covenants on the part of any contractor or subcontractor employed in the performance of this contract.

- 2. The contractor hereby agrees that any and all subcontracts to this contract, whereby a portion of the work set forth in this contract is to be performed, shall contain a covenant the same as hereinabove set forth in Section 1 of this Appendix.
- 3. The contractor will take affirmative action to ensure that applicants for employment and employees are treated without regard to their race, color, religion, national origin, age, sex, height, weight, marital status, or any disability that is unrelated to the individual's ability to perform the duties of a particular job or position. Such action shall include, but not be limited to, the following: employment; treatment; upgrading; demotion or transfer; recruitment; advertising; layoff or termination; rates of pay or other forms of compensation; and selection for training, including apprenticeship.

- In the event that the Michigan Civil Rights Commission finds, after a hearing held 8. pursuant to its rules, that a contractor has not complied with the contractual obligations under this contract, the Michigan Civil Rights Commission may, as a part of its order based upon such findings, certify said findings to the State Administrative Board of the State of Michigan, which State Administrative Board may order the cancellation of the contract found to have been violated and/or declare the contractor ineligible for future contracts with the state and its political and civil subdivisions, departments, and officers, including the governing boards of institutions of higher education, until the contractor complies with said order of the Michigan Civil Rights Commission. Notice of said declaration of future ineligibility may be given to any or all of the persons with whom the contractor is declared ineligible to contract as a contracting party in future contracts. In any case before the Michigan Civil Rights Commission in which cancellation of an existing contract is a possibility, the contracting agency shall be notified of such possible remedy and shall be given the option by the Michigan Civil Rights Commission to participate in such proceedings.
- 9. The contractor shall include or incorporate by reference, the provisions of the foregoing paragraphs (1) through (8) in every subcontract or purchase order unless exempted by rules, regulations, or orders of the Michigan Civil Rights Commission; all subcontracts and purchase orders will also state that said provisions will be binding upon each subcontractor or supplier.

AN ORDINANCE TO AMEND SECTION 58-59 OF THE ST. LOUIS CITY CODE, EXTENDING THE TERM OF THE WOODLAND PLACE (NOW KNOWN AS GREENLAND PLACE), LDHA TAX EXEMPTION FOR ONE ADDITIONAL YEAR

The City of St. Louis Ordains:

Section 1:	This Article shall remain in effect for a period of one year after the previous expiration date of Ordinance B-148 so long as the housing development remains subject to income and rent restrictions pursuant to section 42 of the Internal Revenue Code of 1986, as amended. Amended date of expiration shall be December 31, 2019. At the close of said one-year period, the subject property shall revert to the regular tax tolls of the City
	City.

- Section 2: Separability. If any section, subsection, paragraph, sentence, clause, phrase or portion of this ordinance is, for any reason, held invalid or unconstitutional by any Court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portions thereof.
- Section 3: Ordinances Repealed. All ordinances and/or parts of ordinances inconsistent with this ordinance are hereby repealed.
- Section 4: Effective Date. This ordinance shall take effect and be in force 30 days from and after its enactment as provided by the City Charter.
