The regular meeting of the Saint Louis City Council was called to order by Mayor Thomas L. Reed on Tuesday, September 20, 2022 at 6:00 p.m. in the City Hall Council Chambers.

Public Hearing - Obsolete Property Rehabilitation (OPRA) District.

Mayor Reed opened the Public Hearing at 6:00 p.m.

Mayor Reed asked for Public Comments.

Manager Giles stated an application has been received from 214 N. Mill Street to establish an OPRA District and before the application can be considered, an OPRA District has to be established.

There were no other comments.

Mayor Reed Closed the Public Hearing at 6:04 p.m.

The following preamble and resolution were offered by Member Kubin, and supported by Member Leonard:

Resolution 2022-15 Establishing Obsolete Property Rehabilitation Act (OPRA) District For M.T. Lott LLC.

WHEREAS, pursuant to Act No. 146 of the Public Acts of 2000, the City Council for the City of St. Louis has the authority to establish "Obsolete Property Rehabilitation Act District" within the City of St. Louis; and

WHEREAS, M.T. Lott LLC has filed a written request with the clerk of the City of St. Louis requesting the establishment of an Obsolete Property Rehabilitation Act District on its property located in the City of St. Louis hereinafter described; and

WHEREAS, the City Council of the City of St. Louis sets forth a finding and determination that the district meets the requirements set forth in section 3(1) of Public Acts 146 of 2000; and

WHEREAS, written notice has been given by mail to all owners of real property located within the proposed district, and to the public by newspaper advertisement in the <u>Morning Son</u> <u>Newspaper</u> and/or public posting of the hearing on the establishment of the proposed district; and

WHERAS, on September 20, 2022 a public hearing was held and all residents and taxpayers of the City of St. Louis were afforded an opportunity to be heard thereon; and

WHEREAS, the City Council deems it to be in the public interest of the City of St. Louis to establish the Obsolete Property Rehabilitation Act District as proposed;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of St. Louis that the following described parcel of land situated in the City of St. Louis, County of Gratiot, State of Michigan, to wit:

be and here is established as an Obsolete Property Rehabilitation Act District pursuant to the provision of Act No. 146 of the Public Acts of 2000 to be known as 214 North Mill Street Obsolete Property Rehabilitation Act District No. 2022-02.

Public Hearing – OPRA Exemption Certificate Application.

Mayor Reed opened the Public Hearing at 6:05 p.m.

Mayor Reed asked for Public Comments.

Manager Giles stated the OPRA Exemption Certificate Application is for a period of 10 years. The maximum amount allowed is 12 years.

Resolution 2022-16 Approving Obsolete Property Rehabilitation Exemption Certificate Application for M.T. Lott LLC located at 214 North Mill Street, St. Louis, MI 48880

WHEREAS, pursuant to PA 146 of 2000, the City of St. Louis is a Qualified Local Governmental Unit eligible to establish one or more Obsolete Property Rehabilitation Districts; and

WHEREAS, the taxable value of the property proposed to be exempt plus the aggregate taxable value of property already exempt under Public Act 146 of 2000 and under Public Act 198 of 1974 (IFT's) does not exceed 5% of the total taxable value of the City of St. Louis; and

WHEREAS, the application was approved at a public hearing as provided by section 4(2) of Public Acts 146 of 2000 on September 20, 2022; and

WHEREAS, M.T. Lott LLC is not delinquent in any taxes related to the facility; and

WHEREAS, the application is for obsolete property as defined in section 2(h) of Public Act 146 of 2000; and

WHEREAS, the applicant M.T. Lott LLC has provided answers to all required questions under the application instructions to the City of St. Louis; and

WHEREAS, the City of St. Louis requires that rehabilitation of the facility shall be completed by December 31, 2022; and

WHEREAS, the commencement of the rehabilitation of the facility did not occur before the establishment of the Obsolete Property Rehabilitation District; and

WHEREAS, the application relates to a rehabilitation of the facility did not occur before the establishment of the Obsolete Property Rehabilitation District; and

WHEREAS, the application relates to a rehabilitation program that when completed constitutes a rehabilitated facility within meaning of Public Act 146 of 2000 and that is situated within an Obsolete Property Rehabilitation District established in the City of St. Louis eligible under Public Act 146 of 2000 to establish such a district; and

WHERAS, completion of the rehabilitated facility is calculated to, and will at the time of issuance of the certificate, have the reasonable likelihood to, increase commercial activity, create

employment, revitalize urban areas, and increase the number of residents in the community in which the facility is situated; and

WHEREAS, the rehabilitation includes improvements aggregating 10% or more of the true cash value of the property at commencement of the rehabilitation as provided by section 2(1) of Public Act 146 of 2000.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of St. Louis

Be and hereby is granted an Obsolete Property Rehabilitation Exemption for the real property, excluding land, located in Obsolete Property Rehabilitation District No. 2022-02 at 214 North Mill Street, St. Louis, MI for a period of 10 years, beginning September 21, 2022, and ending December 30, 2032 pursuant to the provisions of PA 146 of 2000, as amended.

Manager Giles requested members approve the Proposal from Dice Excavating for the demolition of the existing salt barn upper structure in the amount of \$11,200.00.
